
IT IS HEREBY ORDERED that:-

1. Each of the Plaintiffs in these actions whether by itself, its servants, officers or agents or otherwise howsoever be restrained until final judgment or further order in the meantime, from taking any further steps of any nature whatsoever in proceedings originally commenced by the Defendant against inter alios the Plaintiffs, in the Arbitration Court of the City of St. Petersburg and the Leningrad Oblast under Case Number A56-15164/2006, and which pursuant to an Order of the St Petersburg Court dated 12th May, 2006 were ordered to be transferred to Khanti Man-Sisk (the "St Petersburg Proceedings"). Without prejudice to the generality of the foregoing the Plaintiffs (and each of them) shall not, without further order of the Court :-
 - (a) enforce or seek to enforce or in any way seek to give effect or otherwise assist in the implementation of the Order made in the St Petersburg Proceedings on 12th July, 2006 transferring the St Petersburg Proceedings to Khanti Man-Sisk, and/or
 - (b) seek to advance or otherwise take any step or steps in relation to the St Petersburg Proceedings, including at or by any other application, filing or otherwise to any court in St Petersburg or in Khanti Man-Sisk;
2. The Orders made herein dated 8th June 2006 be varied, so as to permit the Defendant to take any steps that it is advised are necessary and expedient in the Russian Courts to seek the

may reversal *of the effect* (whether by appeal or otherwise) of the decision of the St Petersburg Court dated 12th July, 2006 to move the venue of the St Petersburg Proceedings to Khanti Man-Sisk;
